MARIE ANTOINETTE

MARIE ANTOINETTE, THE QUEEN CONSORT OF KING LOUIS XVI, IS INFAMOUS FOR HER ALLEGED REMARK, "LET THEM EAT CAKE!" THIS PHRASE, WHETHER APOCRYPHAL OR NOT, EPITOMIZES HER PERCEIVED DISCONNECT FROM THE STRUGGLES OF THE COMMON PEOPLE. HER LAVISH SPENDING DURING A TIME OF FAMINE AND ECONOMIC CRISIS MADE HER A SYMBOL OF ROYAL EXCESS AND IGNORANCE.

GEORGE W. BUSH

THE 43RD PRESIDENT OF THE UNITED STATES, GEORGE W. BUSH, HAS OFTEN BEEN RIDICULED FOR HIS PUBLIC SPEAKING GAFFES AND MISSTATEMENTS. WHILE SOME OF HIS DECISIONS DURING HIS PRESIDENCY WERE CONTENTIOUS, THE PERCEPTION OF HIS INTELLIGENCE WAS FREQUENTLY OVERSHADOWED BY HIS VERBAL BLUNDERS. THIS HAS LED TO A LASTING IMAGE OF HIM AS ONE OF THE LESS INTELLECTUALLY CAPABLE LEADERS IN AMERICAN HISTORY.

NOTABLE EVENTS OF STUPIDITY

THE Y2K SCARE

THE YEAR 2000 BROUGHT WIDESPREAD PANIC OVER THE Y2K BUG, WHERE IT WAS FEARED THAT COMPUTER SYSTEMS WOULD FAIL DUE TO THE CENTURY CHANGE. GOVERNMENTS AND BUSINESSES INVESTED BILLIONS IN PREVENTION MEASURES, YET WHEN THE CLOCK STRUCK MIDNIGHT, VIRTUALLY NOTHING HAPPENED. THIS EVENT HIGHLIGHTED HOW FEAR AND MISINFORMATION CAN LEAD TO OVERREACTIONS AND UNNECESSARY EXPENDITURES.

SOCIETAL IMPACT OF FOOLISHNESS
