UNDERSTANDING THE ROLE OF THE PROCTOR

KEY RESPONSIBILITIES OF PROCTORS

DOCUMENTATION AND REPORTING

ACCURATE DOCUMENTATION IS A VITAL ASPECT OF THE INVESTIGATION PROCESS. PROCTORS ARE REQUIRED TO:

- MAINTAIN DETAILED NOTES ABOUT THE EXAM CONDITIONS AND ANY INCIDENTS THAT OCCURRED.
- COMPLETE INCIDENT REPORTS THAT SUMMARIZE THE FINDINGS AND ACTIONS TAKEN DURING THE INVESTIGATION.
- SUBMIT ALL DOCUMENTATION TO THE APPROPRIATE AUTHORITIES FOR FURTHER REVIEW.

THE THOROUGHNESS OF THE DOCUMENTATION CAN SIGNIFICANTLY IMPACT THE OUTCOME OF ANY DISCIPLINARY PROCEEDINGS.

SIGNIFICANCE OF MAINTAINING EXAM INTEGRITY
