## INTRODUCTION TO EMILE DURKHEIM

[EMILE DURKHEIM](#) (1858-1917) IS WIDELY REGARDED AS ONE OF THE FOUNDING FIGURES OF SOCIOLOGY. HIS WORK LAID THE GROUNDWORK FOR UNDERSTANDING SOCIAL STRUCTURES AND THEIR INFLUENCE ON INDIVIDUAL BEHAVIOR. ## THE CONTEXT OF "THE ELEMENTARY FORMS OF RELIGIOUS LIFE"

## THE IMPORTANCE OF TOTEMISM

DURKHEIM BELIEVES THAT THESE MOMENTS OF COLLECTIVE EXCITEMENT ARE ESSENTIAL FOR THE VITALITY OF RELIGIOUS LIFE AND SOCIETY AS A WHOLE.

## THE ROLE OF RITUALS

RITUALS SERVE AS A MEDIUM THROUGH WHICH THE SACRED IS EXPRESSED AND REINFORCED WITHIN A COMMUNITY. THEY ARE NOT MERELY CEREMONIAL ACTS BUT ARE VITAL FOR THE FUNCTIONING OF SOCIETY. THROUGH RITUALS, INDIVIDUALS REAFFIRM THEIR COLLECTIVE IDENTITY AND RENEW THEIR COMMITMENTS TO THE SOCIAL NORMS AND VALUES THAT BIND THEM TOGETHER. DURKHEIM EMPHASIZES THAT RITUALS ARE FUNDAMENTAL IN MAINTAINING THE SOCIAL ORDER.

## METHODOLOGY AND RESEARCH APPROACH

THIS COMPARATIVE METHOD ENABLES HIM TO HIGHLIGHT THE UNIVERSALITY OF CERTAIN RELIGIOUS PHENOMENA, THEREBY REINFORCING HIS ARGUMENT THAT RELIGION IS A SOCIAL CONSTRUCT RATHER THAN AN INDIVIDUAL EXPERIENCE.

## IMPLICATIONS OF DURKHEIM'S FINDINGS
