UNDERSTANDING EVIDENCE-BASED PRACTICE

EVIDENCE-BASED PRACTICE (EBP) IS DEFINED AS THE CONSCIENTIOUS INTEGRATION OF THE BEST AVAILABLE RESEARCH, CLINICAL EXPERTISE, AND PATIENT VALUES TO FACILITATE CLINICAL DECISION-MAKING. 6. **DISSEMINATING RESULTS:** SHARE FINDINGS AND EXPERIENCES WITH COLLEAGUES, WHICH CAN FOSTER A CULTURE OF EBP WITHIN THE NURSING TEAM.

BY FOLLOWING THESE STEPS, NURSES CAN EFFECTIVELY INCORPORATE EVIDENCE-BASED PRACTICE INTO THEIR DAILY ROUTINES, LEADING TO IMPROVED CARE DELIVERY.

OVERCOMING BARRIERS TO EBP IMPLEMENTATION
