UNDERSTANDING THE FBI PHASE 1 TEST

COMPONENTS OF THE FBI PHASE 1 TEST

COGNITIVE ABILITIES

THESE ABILITIES ARE VITAL FOR MAKING SOUND JUDGMENTS IN HIGH-PRESSURE SITUATIONS. THIS SECTION OFTEN INCLUDES QUESTIONS THAT REQUIRE CANDIDATES TO ANALYZE DATA, DRAW CONCLUSIONS, AND MAKE DECISIONS BASED ON GIVEN INFORMATION.

SITUATIONAL JUDGMENT

THE SITUATIONAL JUDGMENT COMPONENT EVALUATES HOW CANDIDATES RESPOND TO VARIOUS REAL-LIFE SCENARIOS THEY MAY ENCOUNTER AS FBI AGENTS. THIS SECTION TESTS THEIR JUDGMENT, ETHICAL REASONING, AND INTERPERSONAL SKILLS. CANDIDATES MUST SELECT THE BEST COURSE OF ACTION FROM A SET OF OPTIONS, DEMONSTRATING THEIR UNDERSTANDING OF LAW ENFORCEMENT PRINCIPLES AND VALUES.

BEHAVIORAL ASSESSMENT

THE BEHAVIORAL ASSESSMENT FOCUSES ON CANDIDATES' PERSONAL ATTRIBUTES AND MOTIVATIONS. THIS SECTION IS DESIGNED TO GAUGE WHETHER CANDIDATES POSSESS THE TRAITS NECESSARY TO SUCCEED IN A RIGOROUS LAW ENFORCEMENT ENVIRONMENT. CANDIDATES MAY BE ASKED TO RESPOND TO QUESTIONS ABOUT THEIR PAST EXPERIENCES, VALUES, AND HOW THEY HANDLE CHALLENGES.
