THIS NOT ONLY BUILDS FAMILIARITY WITH THE QUESTION FORMAT BUT ALSO HELPS IN DEVELOPING A ROUTINE THAT CAN REDUCE EXAM DAY JITTERS.

PROCRASTINATION

PROCRASTINATION CAN DERAIL EVEN THE BEST-PREPARED CANDIDATES. ESTABLISHING A CLEAR STUDY SCHEDULE WITH SPECIFIC GOALS AND DEADLINES CAN HELP MAINTAIN MOTIVATION AND ENSURE CONSISTENT PROGRESS TOWARD EXAM READINESS.
