 - RETIREMENT ACCOUNTS (401(k), IRA)
- BUSINESS INTERESTS:
 - OWNERSHIP STAKES IN BUSINESSES
 - PARTNERSHIPS
- OTHER ASSETS:
 - LIFE INSURANCE POLICIES WITH CASH VALUE
 - INTELLECTUAL PROPERTY
 - ANY OTHER SIGNIFICANT ASSETS NOT COVERED ABOVE

3. LIABILITIES

JUST AS IT IS ESSENTIAL TO OUTLINE ASSETS, DOCUMENTING LIABILITIES IS EQUALLY IMPORTANT. THIS SECTION SHOULD INCLUDE:

- MORTGAGES:
 - AMOUNTS OWED ON REAL ESTATE PROPERTIES
- LOANS:
 - PERSONAL LOANS
 - STUDENT LOANS
- CREDIT CARD DEBT:
 - TOTAL OUTSTANDING BALANCES ON CREDIT CARDS
- TAXES OWED:
 - ANY TAX DEBTS OR PENDING OBLIGATIONS
- OTHER FINANCIAL OBLIGATIONS:
 - ALIMONY OR CHILD SUPPORT PAYMENTS
 - ANY OTHER DEBTS

4. VALUATION OF ASSETS AND LIABILITIES

ASSIGNING A VALUE TO EACH ASSET AND LIABILITY IS CRUCIAL FOR A FAIR DIVISION. THIS SECTION MAY INCLUDE:

- ESTIMATED MARKET VALUE FOR REAL ESTATE AND PERSONAL PROPERTY.
- CURRENT BALANCE FOR FINANCIAL ACCOUNTS.
- OUTSTANDING BALANCES FOR LIABILITIES.
