ELIGIBILITY REQUIREMENTS

AGE AND EDUCATION

A: NO, CANDIDATES CANNOT LEGALLY WORK AS ESTHETICIANS UNTIL THEY HAVE PASSED THE STATE BOARD EXAM AND OBTAINED THEIR LICENSE. IT IS IMPORTANT TO WAIT FOR THE OFFICIAL RESULTS AND COMPLETE THE LICENSURE PROCESS BEFORE PRACTICING.

Q: ARE THERE ANY AGE RESTRICTIONS TO APPLY FOR THE GEORGIA ESTHETICIAN STATE BOARD EXAM?
