HIS LEGACY INCLUDES NUMEROUS LIBRARIES AND EDUCATIONAL INSTITUTIONS THROUGHOUT THE UNITED STATES.

JOHN D. ROCKEFELLER

JOHN D. ROCKEFELLER FOUNDED THE STANDARD OIL COMPANY, BECOMING ONE OF THE WEALTHIEST INDIVIDUALS IN HISTORY. HIS BUSINESS PRACTICES PROMPTED THE DEVELOPMENT OF ANTITRUST LAWS AS CONCERNS OVER MONOPOLISTIC PRACTICES GREW. ROCKEFELLER'S PHILANTHROPY ALSO CONTRIBUTED TO MEDICAL RESEARCH AND EDUCATION.

POLITICAL LANDSCAPE

THE POLITICAL ENVIRONMENT OF THE GILDED AGE WAS CHARACTERIZED BY CORRUPTION AND THE INFLUENCE OF BIG BUSINESS ON GOVERNMENT. POLITICAL MACHINES, SUCH AS TAMMANY HALL IN NEW YORK CITY, WIELDED SIGNIFICANT POWER, OFTEN ENGAGING IN CORRUPT PRACTICES TO MAINTAIN CONTROL.

KEY STRIKES AND UNIONS

SEVERAL SIGNIFICANT STRIKES OCCURRED DURING THE GILDED AGE, HIGHLIGHTING THE GROWING TENSIONS BETWEEN LABOR AND MANAGEMENT. THE GREAT RAILROAD STRIKE OF 1877 AND THE HAYMARKET AFFAIR OF 1886 WERE PIVOTAL EVENTS THAT
