UNDERSTANDING GRAPHIC ORGANIZERS

- **MIND MAP:** A VISUAL REPRESENTATION THAT STARTS WITH A CENTRAL IDEA AND BRANCHES OUT TO SHOW RELATED POINTS AND SUBPOINTS.
- **PROS AND CONS LIST:** A SIMPLE ORGANIZER THAT HELPS WRITERS TO WEIGH THE ADVANTAGES AND DISADVANTAGES OF A PARTICULAR ARGUMENT OR POSITION.

BENEFITS OF USING GRAPHIC ORGANIZERS

CREATING EFFECTIVE GRAPHIC ORGANIZERS

3. **IDENTIFY KEY POINTS:** LIST THE MAIN ARGUMENTS AND SUPPORTING EVIDENCE THAT WILL BE INCLUDED IN THE ORGANIZER.

4. **ORGANIZE LOGICALLY:** ARRANGE THE POINTS IN A LOGICAL ORDER THAT FLOWS NATURALLY AND SUPPORTS THE PERSUASIVE ARGUMENT EFFECTIVELY.
5. **REVISE AND ADJUST:** AFTER CREATING THE INITIAL DRAFT OF THE GRAPHIC ORGANIZER, REVIEW IT FOR CLARITY AND EFFECTIVENESS, MAKING ADJUSTMENTS AS NECESSARY.

PRACTICAL EXAMPLES OF GRAPHIC ORGANIZERS

- SUPPORTING EVIDENCE: STATISTICS ON INCREASING HURRICANES AND FLOODS.
- MAIN ARGUMENT 2: "CLIMATE CHANGE IS CAUSING SPECIES EXTINCTION."
- COUNTERARGUMENT: "SOME ARGUE THAT CLIMATE CHANGE IS A NATURAL CYCLE."
- REBUTTAL: "HOWEVER, SCIENTIFIC EVIDENCE SHOWS HUMAN IMPACT IS SIGNIFICANT."

EXAMPLE 2: PROS AND CONS LIST

IN A DEBATE ABOUT SCHOOL UNIFORMS, A PROS AND CONS LIST CAN EFFECTIVELY ORGANIZE ARGUMENTS:

- **PROS:**
 - PROMOTES EQUALITY AMONG STUDENTS.
 - REDUCES DISTRACTIONS RELATED TO CLOTHING.
 - ENHANCES SCHOOL SPIRIT.
- **CONS:**
 - LIMITS PERSONAL EXPRESSION.

- CAN BE FINANCIALLY BURDENSOME FOR SOME FAMILIES.
- MAY NOT ADDRESS THE ROOT CAUSES OF BULLYING.
