THE EARLY LIFE OF HABEN GIRMA

HABEN GIRMA WAS BORN ON JULY 29, 1988, IN OAKLAND, CALIFORNIA. HER EARLY LIFE WAS MARKED BY CHALLENGES THAT WOULD SHAPE HER INTO THE FORMIDABLE ADVOCATE SHE IS TODAY.

GROWING UP DEAFBLIND

FROM BIRTH, HABEN FACED THE DUAL CHALLENGES OF BEING DEAF AND BLIND. HER CONDITION WAS A RESULT OF A RARE GENETIC DISORDER, AND SHE HAD TO NAVIGATE A WORLD THAT OFTEN SAW HER AS LIMITED. YET, HER PARENTS WERE DETERMINED TO PROVIDE HER WITH A RICH AND FULFILLING LIFE. THEY INSTILLED IN HER THE BELIEF THAT SHE COULD ACHIEVE ANYTHING SHE SET HER MIND TO.

- **SUPPORTIVE FAMILY:** HABEN'S PARENTS PLAYED A CRUCIAL ROLE IN HER DEVELOPMENT BY ENCOURAGING HER TO COMMUNICATE AND LEARN IN WAYS THAT WORKED FOR HER. THEY ADVOCATED FOR HER RIGHT TO AN EDUCATION AND ACCESS TO RESOURCES.
- **EARLY EDUCATION:** SHE ATTENDED A SPECIAL EDUCATION SCHOOL WHERE SHE LEARNED TO READ AND COMMUNICATE USING BRAILLE AND TACTILE SIGN LANGUAGE. THIS EARLY FOUNDATION SET THE STAGE FOR HER FUTURE ACADEMIC SUCCESS.

- **STUDENT LEADERSHIP:** SHE TOOK ON LEADERSHIP ROLES IN STUDENT ORGANIZATIONS AND WORKED TO PROMOTE INCLUSIVITY ON CAMPUS.
- **INTERNSHIPS:** THROUGH INTERNSHIPS AND VOLUNTEER WORK, HABEN GAINED VALUABLE EXPERIENCE IN ADVOCACY AND PUBLIC SERVICE, FURTHER IGNITING HER PASSION FOR SOCIAL JUSTICE.
