HAIR AND FIBER EVIDENCE WORKSHEET

THE ANALYSIS OF HAIR AND FIBER EVIDENCE IS A CRUCIAL COMPONENT IN FORENSIC SCIENCE, AIDING IN THE INVESTIGATION OF CRIMES AND THE IDENTIFICATION OF INDIVIDUALS INVOLVED. - ASSOCIATION: LINKING SUSPECTS TO VICTIMS OR CRIME SCENES.
- EXCLUSION: ELIMINATING POTENTIAL SUSPECTS FROM AN INVESTIGATION.
- IDENTIFICATION: PROVIDING INFORMATION ABOUT THE TYPE, SOURCE, AND CHARACTERISTICS OF THE MATERIALS INVOLVED.

TYPES OF HAIR EVIDENCE

HAIR EVIDENCE CAN BE CATEGORIZED INTO TWO MAIN TYPES:

1. HUMAN HAIR: THIS TYPE OF HAIR IS OFTEN ANALYZED TO DETERMINE IF IT ORIGINATES FROM A PARTICULAR INDIVIDUAL. HUMAN HAIR CAN BE FURTHER CLASSIFIED INTO:
 - HEAD HAIR: TYPICALLY LONGER AND MAY EXHIBIT A VARIETY OF CHARACTERISTICS SUCH AS COLOR, THICKNESS, AND TEXTURE.

 - FACIAL HAIR: INCLUDES BEARD AND MUSTACHE HAIR, WHICH CAN DIFFER SIGNIFICANTLY FROM OTHER TYPES.
2. ANIMAL HAIR: ANIMAL HAIR CAN ALSO BE SIGNIFICANT IN INVESTIGATIONS. EACH SPECIES HAS DISTINCT CHARACTERISTICS, AND THE ANALYSIS CAN HELP DETERMINE THE TYPE OF ANIMAL INVOLVED. KEY POINTS INCLUDE:

TYPES OF FIBER EVIDENCE

EACH TYPE OF FIBER HAS ITS UNIQUE PROPERTIES, WHICH CAN AID IN FORENSIC ANALYSIS.

 - CONDITION OF THE EVIDENCE AT THE TIME OF COLLECTION
 - ANY POTENTIAL CONTAMINATION CONCERNS
4. ANALYSIS INFORMATION:
 - LABORATORY CONDUCTING THE ANALYSIS
 - DATE OF ANALYSIS
 - TECHNIQUES USED (MICROSCOPY, DNA ANALYSIS, ETC.)
 - RESULTS OF THE ANALYSIS
5. CHAIN OF CUSTODY:
 - DOCUMENTATION OF ALL INDIVIDUALS WHO HANDLED THE EVIDENCE
 - DATES AND TIMES OF EACH TRANSFER
 - SIGNATURES CONFIRMING CUSTODY

COLLECTION AND PRESERVATION OF HAIR AND FIBER EVIDENCE

THE PROPER COLLECTION AND PRESERVATION OF HAIR AND FIBER EVIDENCE ARE PARAMOUNT TO MAINTAINING ITS INTEGRITY AND ENSURING ITS ADMISSIBILITY IN COURT. FOLLOWING BEST PRACTICES CAN SIGNIFICANTLY ENHANCE THE QUALITY OF THE EVIDENCE COLLECTED.

COLLECTION TECHNIQUES
