CULTURAL EXCHANGE AND SYNCRETISM

IMPACT ON RELIGION AND BELIEFS

RESISTANCE AND ADAPTATION

DESPITE THE CONVERSION EFFORTS, MANY INDIGENOUS COMMUNITIES RESISTED EUROPEAN RELIGIOUS IMPOSITIONS, STRIVING TO MAINTAIN THEIR CULTURAL IDENTITY. THIS RESISTANCE WAS NOT ONLY SPIRITUAL BUT ALSO MANIFESTED IN SOCIAL AND POLITICAL STRUCTURES, LEADING TO UPRISINGS AND MOVEMENTS THAT CHALLENGED COLONIAL AUTHORITY.

SOCIOECONOMIC CHANGES AND COLONIAL STRUCTURES

SOCIAL HIERARCHIES

COLONIAL SOCIETY DEVELOPED RIGID SOCIAL HIERARCHIES BASED ON RACE AND ETHNICITY, OFTEN PRIVILEGING EUROPEAN DESCENDANTS OVER INDIGENOUS PEOPLES AND ENSLAVED AFRICANS. THIS STRATIFICATION HAS HAD LASTING EFFECTS ON SOCIAL DYNAMICS AND INEQUALITIES THAT PERSIST IN MANY LATIN AMERICAN COUNTRIES TODAY.
