

HISTORY OF POLITICAL PARTIES IN TEXAS

HOWEVER, THE WHIG PARTY'S INFLUENCE WANED AFTER THE 1850S, LARGELY DUE TO INTERNAL DIVISIONS OVER SLAVERY.
3. REPUBLICAN PARTY: THE REPUBLICAN PARTY WAS FOUNDED IN THE 1850S AS AN ANTI-SLAVERY PARTY. WHILE IT STRUGGLED TO GAIN TRACTION IN TEXAS DURING THE ANTEBELLUM PERIOD, ITS INFLUENCE GREW AFTER THE CIVIL WAR, PARTICULARLY DURING RECONSTRUCTION.

THE CIVIL WAR AND RECONSTRUCTION ERA

THE CIVIL WAR (1861-1865) AND THE SUBSEQUENT RECONSTRUCTION PERIOD HAD A PROFOUND IMPACT ON TEXAS'S POLITICAL PARTIES. THE DEMOCRATIC PARTY CONSOLIDATED ITS POWER BY ALIGNING ITSELF WITH THE CONFEDERACY, WHILE THE REPUBLICAN PARTY WAS ASSOCIATED WITH THE UNION AND RECONSTRUCTION EFFORTS.

POST-WAR POLITICS

THE DEMOCRATIC PARTY'S PLATFORM DURING THIS ERA FOCUSED ON:

- AGRARIAN INTERESTS: THE DEMOCRATS SUPPORTED THE INTERESTS OF FARMERS AND RANCHERS, ADVOCATING FOR POLICIES THAT FAVORED RURAL DEVELOPMENT.

THE RISE OF POPULISM AND THE PROGRESSIVE ERA

THE MID-20TH CENTURY: A POLITICAL REALIGNMENT

THE MID-20TH CENTURY MARKED A SIGNIFICANT SHIFT IN TEXAS POLITICS. THE CIVIL RIGHTS MOVEMENT AND THE CHANGING NATIONAL POLITICAL LANDSCAPE LED TO A GRADUAL DECLINE IN THE DEMOCRATIC PARTY'S DOMINANCE.

THE MODERN ERA: REPUBLICAN DOMINANCE
