- **COLLECT YOUR PASSPORT:** GATHER YOUR PASSPORT AND CHECK FOR STAMPS FROM VARIOUS COUNTRIES YOU HAVE VISITED.
- **CREATE A LOG:** LIST THE DATES AND LOCATIONS OF YOUR TRAVELS BASED ON THE PASSPORT STAMPS. THIS LOG CAN HELP YOU KEEP TRACK OF YOUR TRIPS.
- **CROSS-REFERENCE WITH OTHER RECORDS:** IF YOU HAVE TRAVEL ITINERARIES, BOARDING PASSES, OR RECEIPTS, CROSS-REFERENCE THESE DOCUMENTS WITH YOUR PASSPORT STAMPS TO ENSURE ACCURACY.

3. CHECKING WITH AIRLINES AND TRAVEL AGENCIES

IF YOU FREQUENTLY TRAVEL BY AIR, AIRLINES AND TRAVEL AGENCIES CAN ALSO PROVIDE TRAVEL HISTORY:

- **CONTACT YOUR AIRLINES:** MANY AIRLINES MAINTAIN RECORDS OF YOUR PAST FLIGHTS. PROVIDE THEM WITH YOUR FREQUENT FLYER NUMBER OR PERSONAL DETAILS TO RETRIEVE YOUR TRAVEL HISTORY.
- **ACCESS TRAVEL AGENCY RECORDS:** IF YOU BOOKED THROUGH A TRAVEL AGENCY, REACH OUT TO THEM FOR A DETAILED REPORT OF YOUR ITINERARIES AND TRAVEL HISTORY.

4. REVIEW TAX RETURNS AND FINANCIAL STATEMENTS

FOR ADDITIONAL VERIFICATION, YOU CAN CHECK YOUR FINANCIAL RECORDS:

- **TAX RETURNS:** IF YOU TRAVELED INTERNATIONALLY, YOUR TAX RETURNS MAY INCLUDE INFORMATION ABOUT FOREIGN INCOME, WHICH CAN HELP PINPOINT TRAVEL DATES.
- **BANK STATEMENTS:** REVIEW YOUR BANK STATEMENTS FOR TRANSACTIONS MADE ABROAD, WHICH CAN PROVIDE FURTHER EVIDENCE OF YOUR TRAVEL DATES.

MAINTAINING AN ACCURATE TRAVEL HISTORY

ITINERARIES, AND HOTEL BOOKINGS.

- ORGANIZE BY YEAR: CREATE A FILING SYSTEM TO ORGANIZE THESE DOCUMENTS BY YEAR FOR EASY ACCESS.

3. Use Digital Tools

- TRAVEL APPS: CONSIDER USING TRAVEL APPS THAT AUTOMATICALLY LOG YOUR FLIGHTS AND TRIPS, MAKING IT EASIER TO TRACK YOUR TRAVEL HISTORY.

- CLOUD STORAGE: UTILIZE CLOUD STORAGE SERVICES TO SAVE DIGITAL COPIES OF YOUR TRAVEL DOCUMENTATION, ENSURING THEY ARE ACCESSIBLE FROM ANYWHERE.

IMPACT OF TRAVEL ON GREEN CARD STATUS

UNDERSTANDING THE IMPACT OF TRAVEL ON YOUR GREEN CARD STATUS IS ESSENTIAL FOR LONG-TERM COMPLIANCE.

1. SHORT TRIPS VS. LONG ABSENCES

- SHORT TRIPS: GENERALLY, SHORT TRIPS (LESS THAN 6 MONTHS) DO NOT AFFECT YOUR RESIDENCY STATUS.

- LONG ABSENCES: ABSENCES OF MORE THAN 6 MONTHS MAY PROMPT SCRUTINY REGARDING YOUR INTENT TO REMAIN A PERMANENT RESIDENT. IF YOU ANTICIPATE BEING AWAY FOR OVER A YEAR, CONSIDER APPLYING FOR A RE-ENTRY PERMIT.

2. RE-ENTRY PERMITS

- PURPOSE: A RE-ENTRY PERMIT ALLOWS GREEN CARD HOLDERS TO REMAIN OUTSIDE THE U.S. FOR UP TO TWO YEARS WITHOUT LOSING THEIR PERMANENT RESIDENT STATUS.

- APPLICATION PROCESS: APPLY FOR A RE-ENTRY PERMIT THROUGH FORM I-131 BEFORE LEAVING THE U.S. THIS PROCESS TYPICALLY REQUIRES BIOMETRIC APPOINTMENTS AND APPROVAL FROM USCIS.

IT IS ADVISABLE FOR GREEN CARD HOLDERS TO CHECK THEIR TRAVEL HISTORY REGULARLY, ESPECIALLY BEFORE APPLYING FOR CITIZENSHIP OR RE-ENTERING THE U.S.

CAN THIRD PARTIES ACCESS A GREEN CARD HOLDER'S TRAVEL HISTORY?

NO, A THIRD PARTY CANNOT ACCESS A GREEN CARD HOLDER'S TRAVEL HISTORY WITHOUT THEIR CONSENT DUE TO PRIVACY REGULATIONS.
