UNDERSTANDING APA CITATION STYLE

KEY ELEMENTS OF APA CITATION

WHEN CONSTRUCTING AN APA CITATION, THERE ARE SEVERAL KEY COMPONENTS TO KEEP IN MIND:

1. AUTHOR(S): THE SURNAME FOLLOWED BY THE INITIALS.
2. PUBLICATION YEAR: THE YEAR THE SOURCE WAS PUBLISHED.
3. TITLE OF THE WORK: THE TITLE SHOULD BE ITALICIZED.
4. EDITION: IF APPLICABLE, MENTION THE EDITION OF THE SOURCE.
5. PUBLISHER: THE ORGANIZATION RESPONSIBLE FOR PUBLISHING THE WORK.
6. DOI OR URL: IF AVAILABLE, INCLUDE THE DIGITAL OBJECT IDENTIFIER (DOI) OR THE WEB ADDRESS.

EACH OF THESE ELEMENTS PLAYS A PIVOTAL ROLE IN CREATING A CITATION THAT ADHERES TO APA GUIDELINES.

CITING THE DAVIS DRUG GUIDE

THE DAVIS DRUG GUIDE CAN BE CITED IN VARIOUS FORMS DEPENDING ON THE SPECIFIC VERSION YOU ARE USING (PRINT OR ONLINE) AND WHETHER IT HAS MULTIPLE AUTHORS OR EDITORS. BELOW, WE WILL OUTLINE THE FORMATS FOR DIFFERENT TYPES OF CITATIONS.

PRINT EDITION CITATION

FOR THE PRINT EDITION OF THE DAVIS DRUG GUIDE, FOLLOW THIS FORMAT:

FORMAT:

AUTHOR(S). (YEAR). *TITLE OF THE WORK* (EDITION). PUBLISHER.

EXAMPLE:

ALDRICH, M. M., & LACEY, S. (2021). *DAVIS'S DRUG GUIDE FOR NURSES* (17TH ED.). F.A. DAVIS COMPANY.

IN THIS EXAMPLE, NOTICE HOW THE AUTHORS' NAMES ARE FORMATTED, THE PUBLICATION YEAR IS ENCLOSED IN PARENTHESES, AND THE TITLE IS ITALICIZED.

ONLINE EDITION CITATION

FOR THE ONLINE EDITION, THE CITATION FORMAT SLIGHTLY CHANGES TO INCLUDE A URL OR DOI.

FORMAT:

AUTHOR(S). (YEAR). TITLE OF THE WORK (EDITION). PUBLISHER. URL OR DOI

EXAMPLE:

ALDRICH, M. M., & LACEY, S. (2021). DAVIS'S DRUG GUIDE FOR NURSES (17TH ED.). F.A. DAVIS COMPANY.

WHEN CITING ONLINE RESOURCES, ENSURE THAT THE URL IS FUNCTIONAL AND LEADS DIRECTLY TO THE SOURCE MATERIAL.

MULTIPLE AUTHORS OR EDITORS

IF THE DAVIS DRUG GUIDE HAS MULTIPLE AUTHORS OR EDITORS, LIST THEM IN THE ORDER THEY APPEAR ON THE TITLE PAGE, SEPARATING EACH BY A COMMA AND USING AN AMPERSAND (&) BEFORE THE LAST AUTHOR.

FORMAT:

AUTHOR1, A. A., AUTHOR2, B. B., & AUTHOR3, C. C. (YEAR). TITLE OF THE WORK (EDITION). PUBLISHER.

EXAMPLE:

ALDRICH, M. M., LACEY, S., & TATUM, L. (2021). DAVIS'S DRUG GUIDE FOR NURSES (17TH ED.). F.A. DAVIS COMPANY.

IN-TEXT CITATIONS

IN ADDITION TO FULL CITATIONS IN THE REFERENCE LIST, YOU WILL ALSO NEED TO CREATE IN-TEXT CITATIONS WHEN YOU REFER TO THE DAVIS DRUG GUIDE WITHIN YOUR WRITING. APA STYLE USES THE AUTHOR-DATE METHOD FOR IN-TEXT CITATIONS.

FORMAT:

(AUTHOR, YEAR)

EXAMPLE:

(ALDRICH & LACEY, 2021)

IF YOU ARE QUOTING DIRECTLY FROM THE SOURCE, INCLUDE THE PAGE NUMBER AS WELL:

FORMAT:

(AUTHOR, YEAR, P. PAGE NUMBER)

EXAMPLE:

(ALDRICH & LACEY, 2021, p. 45)

COMMON MISTAKES TO AVOID

WHEN CITING THE DAVIS DRUG GUIDE IN APA FORMAT, SEVERAL COMMON MISTAKES CAN LEAD TO INACCURACIES. BEING AWARE OF THESE PITFALLS CAN HELP YOU PRODUCE A MORE EFFECTIVE CITATION.

1. INCORRECT AUTHOR ORDER: ALWAYS LIST AUTHORS IN THE ORDER THEY APPEAR IN THE PUBLICATION.
2. OMITTING THE EDITION: IF YOU ARE USING A SPECIFIC EDITION OF THE DAVIS DRUG GUIDE, BE SURE TO INCLUDE IT IN YOUR CITATION.
3. NEGLECTING TO ITALICIZE THE TITLE: THE TITLE OF THE DAVIS DRUG GUIDE SHOULD ALWAYS BE ITALICIZED IN YOUR

CITATIONS.

4. IMPROPER FORMATTING OF IN-TEXT CITATIONS: ENSURE THAT YOUR IN-TEXT CITATIONS MATCH THE REFERENCE LIST ENTRY.

DAVIS, J. (2020). DAVIS'S DRUG GUIDE FOR NURSES (16TH ED.). F.A. DAVIS COMPANY.

FREQUENTLY ASKED QUESTIONS

WHAT IS THE CORRECT FORMAT FOR CITING DAVIS DRUG GUIDE IN APA STYLE?

THE CORRECT FORMAT IS: AUTHOR(S). (YEAR). TITLE OF THE BOOK (EDITION). PUBLISHER.

How do I cite the online version of Davis Drug Guide in APA?

For the online version, use: Author(s). (Year). Title of the book. Retrieved from URL

Are there specific authors for Davis Drug Guide that I should include in my citation?

Yes, include the editors or authors listed in the guide. Typically, it is edited by a team of professionals.

Do I need to include the edition number when citing Davis Drug Guide?

Yes, always include the edition number if it is not the first edition. Format it as (Edition) after the title.

If I use a specific chapter from Davis Drug Guide, how should I cite it?

Cite it as a chapter: Author(s) of the chapter. (Year). Title of the chapter. In Editor(s) (Eds.), Title of the book (Edition, pp. pages). Publisher.

The publication year should be placed in parentheses directly after the author(s) in your citation.

Is it necessary to include the DOI for Davis Drug Guide in my citation?

If the online version has a DOI, include it at the end of your citation. Format it as: <https://doi.org/xxxxx>.

What if I cannot find the author information for Davis Drug Guide?

If no authors are listed, begin your citation with the title of the guide instead.

Can I cite Davis Drug Guide in my reference list without a publisher name?

No, the publisher name is essential in APA citations. If it's not available, indicate 'n.p.' for no publisher.

How do I handle multiple authors when citing Davis Drug Guide in APA style?

List up to 20 authors in the citation. If there are more than 20, list the first 19, then use '...' followed by the last author's name.
