COMMUNITY REACTIONS

PSYCHOLOGICAL AND SOCIAL IMPACT

SUPPORT SYSTEMS

IN THE WAKE OF THE SENTENCING, VARIOUS SUPPORT SYSTEMS EMERGED TO ASSIST THOSE AFFECTED. COMMUNITY GROUPS AND MENTAL HEALTH ORGANIZATIONS OFFERED RESOURCES TO HELP INDIVIDUALS COPE WITH THE TRAUMA ASSOCIATED WITH THE CASE.
