

IF THESE WALLS COULD TALK 1

IF THESE WALLS COULD TALK 1 IS A POIGNANT EXPLORATION OF THE COMPLEXITIES SURROUNDING PREGNANCY AND ABORTION, DELIVERED THROUGH A POWERFUL NARRATIVE THAT SPANS SEVERAL DECADES AND THE LIVES OF MULTIPLE WOMEN. ADVOCACY, MAKING IT A VITAL PIECE OF CINEMATIC HISTORY THAT CONTINUES TO INSPIRE AND PROVOKE THOUGHT.
