CORRECT ANSWER: FALSE

3. SCENARIO-BASED QUESTIONS

SCENARIO-BASED QUESTIONS REQUIRE CANDIDATES TO ANALYZE A SITUATION AND PROVIDE A SOLUTION OR MAKE A DECISION BASED ON THEIR KNOWLEDGE. AN EXAMPLE QUESTION COULD BE:

- A CREW MEMBER REPORTS A NEAR-MISS INCIDENT DURING OPERATIONS. WHAT SHOULD BE YOUR IMMEDIATE COURSE OF ACTION?

CANDIDATES WOULD NEED TO DEMONSTRATE THEIR UNDERSTANDING OF INCIDENT REPORTING AND FOLLOW-UP PROCEDURES.

4. TECHNICAL QUESTIONS
