PARALEGALS MUST DEMONSTRATE A KEEN EYE FOR DETAIL, ENSURING THAT ALL LEGAL DOCUMENTS ARE ACCURATE AND COMPLETE TO AVOID COSTLY MISTAKES.

## 5. CRITICAL THINKING

THE ABILITY TO ANALYZE SITUATIONS, ASSESS LEGAL ISSUES, AND PROPOSE SOLUTIONS IS VITAL FOR PARALEGALS, ESPECIALLY WHEN CONDUCTING RESEARCH OR DRAFTING LEGAL DOCUMENTS.

## EDUCATIONAL PATHWAYS IN PARALEGAL STUDIES

- NATIONAL FEDERATION OF PARALEGAL ASSOCIATIONS (NFPA): PROVIDES THE PARALEGAL ADVANCED COMPETENCY EXAM (PACE).
- AMERICAN ALLIANCE OF PARALEGALS, INC. (AAP): OFFERS THE AMERICAN ALLIANCE CERTIFIED PARALEGAL (AACP) CREDENTIAL.
