THE INTERNATIONAL AIR TRANSPORT ASSOCIATION (IATA) ESTABLISHED THE ISAGO (IATA SAFETY AUDIT FOR GROUND OPERATIONS) PROGRAM TO PROMOTE SAFETY AND EFFICIENCY IN GROUND HANDLING OPERATIONS WORLDWIDE. - **BUILDING TRUST:** BY ACHIEVING ISAGO CERTIFICATION, GROUND HANDLING COMPANIES CAN DEMONSTRATE THEIR COMMITMENT TO SAFETY AND QUALITY, FOSTERING TRUST AMONG AIRLINES AND CUSTOMERS.

KEY COMPONENTS OF THE ISAGO STANDARDS MANUAL

THE ISAGO STANDARDS MANUAL COMPRISES SEVERAL CRITICAL COMPONENTS THAT GROUND SERVICE PROVIDERS MUST IMPLEMENT TO ACHIEVE CERTIFICATION. THESE COMPONENTS ENSURE THAT ALL ASPECTS OF GROUND HANDLING OPERATIONS ARE ADDRESSED COMPREHENSIVELY.

1. SAFETY MANAGEMENT SYSTEM (SMS)

A ROBUST SAFETY MANAGEMENT SYSTEM IS THE BACKBONE OF THE ISAGO STANDARDS. IT INVOLVES:

- IDENTIFYING HAZARDS AND ASSESSING RISKS
- ESTABLISHING SAFETY OBJECTIVES AND POLICIES
- IMPLEMENTING SAFETY TRAINING PROGRAMS
- CONTINUOUSLY MONITORING AND IMPROVING SAFETY PERFORMANCE

2. GROUND HANDLING OPERATIONS

THE MANUAL DETAILS SPECIFIC PROCEDURES FOR VARIOUS GROUND HANDLING OPERATIONS, INCLUDING:

- AIRCRAFT LOADING AND UNLOADING
- BAGGAGE HANDLING
- AIRCRAFT MARSHALING
- RAMP OPERATIONS
- CARGO HANDLING

EACH OPERATION HAS STANDARDIZED PROCEDURES TO ENSURE SAFETY AND EFFICIENCY.

3. TRAINING AND COMPETENCY

THE ISAGO CERTIFICATION PROCESS

ACHIEVING ISAGO CERTIFICATION IS A STRUCTURED PROCESS THAT INVOLVES SEVERAL STEPS. UNDERSTANDING THESE STEPS CAN HELP GROUND SERVICE PROVIDERS PREPARE FOR THE AUDIT AND SUCCESSFULLY ATTAIN CERTIFICATION.

1. PREPARATION FOR THE AUDIT

BEFORE UNDERGOING THE ISAGO AUDIT, ORGANIZATIONS SHOULD:

- REVIEW THE ISAGO STANDARDS MANUAL THOROUGHLY
- CONDUCT INTERNAL AUDITS TO IDENTIFY GAPS IN COMPLIANCE
- DEVELOP ACTION PLANS TO ADDRESS ANY DEFICIENCIES

2. APPLICATION FOR ISAGO AUDIT

ONCE PREPARED, GROUND SERVICE PROVIDERS MUST SUBMIT AN APPLICATION FOR THE AUDIT, WHICH INCLUDES:

- PROVIDING NECESSARY DOCUMENTATION
- PAYING THE APPLICABLE FEES
- COORDINATING WITH IATA FOR SCHEDULING THE AUDIT

3. CONDUCTING THE AUDIT

THE AUDIT ITSELF INVOLVES:

- A COMPREHENSIVE EVALUATION OF THE GROUND HANDLING OPERATIONS
- INTERVIEWS WITH STAFF AND MANAGEMENT
- OBSERVATIONS OF DAILY OPERATIONS AND PROCEDURES

4. AUDIT RESULTS AND CORRECTIVE ACTIONS

AFTER THE AUDIT, THE FINDINGS WILL BE COMMUNICATED, INCLUDING:

- AREAS OF COMPLIANCE AND NON-COMPLIANCE
- RECOMMENDATIONS FOR CORRECTIVE ACTIONS
- A TIMELINE FOR ADDRESSING ANY IDENTIFIED ISSUES

5. CERTIFICATION ISSUANCE

UPON SUCCESSFUL COMPLETION OF CORRECTIVE ACTIONS, ISAGO CERTIFICATION WILL BE GRANTED. THIS CERTIFICATION IS VALID FOR THREE YEARS, AFTER WHICH A RE-AUDIT IS REQUIRED TO MAINTAIN COMPLIANCE.

BENEFITS OF IMPLEMENTING ISAGO STANDARDS
