This reference implicitly confirms Jesus's existence and his designation as "Christ" among his followers.

These external sources, while not providing detailed accounts of Jesus's life, serve as independent attestation to his existence, his execution, and the rapid emergence of his followers. They demonstrate that Jesus was a known historical figure, not merely a mythical creation, and that his impact was significant enough to be noted by contemporary historians, albeit from a critical or neutral perspective. The convergence of these independent testimonies strengthens the historical case for Jesus of Nazareth.
